ALL monies received by the San Diego High School Finance Office for payment of IB Registration and Exam fees will be transferred to the San Diego Unified School District (SDUSD), who will submit a single payment to the International Baccalaureate Organization (IBO) for payment of the total invoice of all IB Assessment fees.

AGREEMENT: We understand and abide by the following:

- Any changes made <u>prior</u> to Nov. 14, 2019 <u>will not</u> incur any additional costs.
- Any changes made <u>after</u> Nov. 14, 2019 <u>will</u> incur additional costs.
- Prior to January 15, 2020, refunds will be made by the IBO for the per Subject Fees for all Candidates. Additionally, refunds will be made, if applicable, for the Core Fees for Coursework Candidates
- No refunds will be given for ANY reason by the IBO after January 15, 2020.

In accordance with IBO regulations, if the student is taking an IB course and has registered for the IBO Assessments in that subject, they MUST complete ALL the required IB Components (guided coursework, internal/external assessments) for the course.

Note: Students who do not complete and submit all the IBO Course Assessments (IA and EA, including the exams), will still meet SDUSD and CA standards, but will NOT meet IBO curriculum standards. Therefore, these students will NOT receive the IB Course Name and Weighted/Honors credit (if applicable) on the SDUSD Transcript.

In accordance with IBO regulations, if the student is registered for the IBO Assessments and does NOT complete ALL the IB Components by the SDHS International Studies established due dates, the student will still be responsible for any outstanding IBO invoices.

If a student is registered for the IBO Assessments, and is eligible for a subsidy as per Step 2: Statement of Income Eligibility 2019-2020, AND does not complete all the IB Components, they are responsible for the repayment of the subsidy.
